1/ I have a rice mill by the name of Abhishek Industries in Dhamtari on Raipur Road which I am running on rent from 2010. Its owner is Sudhir Singhal.

2/ I also do the work of Government custom milling in mu above rice mill under which I take paddy from Markfed and after making rice from it deposit it in Nagrik Apurti Nigam and FCI godowns. About one and a half years from now ACB officers had called me and asked me whether I bribe NAN people then I had told them that I do not bribe.

Note- At this stage deputy director Mithlesh Varma declared the witness hostile and sought permission to ask the type of questions which are asked in cross examination. After perusal of the record permission is given.

3/ It is wrong to say that problem of space is always there in NAN godowns of Dhamtari while depositing rice. It is wrong to say that collection at the rate of Rs 8/- per quintal was done by officers of Nagrik Apurti Nigam for making space and for compromising on quality and for providing other facilities. It is wrong to say that if we did not give the money then rice was returned by officers of NAN by showing broken more than the standard quality. It is wrong to say that loss of transport expenditure and labor expenditure happened on bringing back the rice. It is wrong to say that to avoid this loss we were compelled to give the money to the quality inspector and district manager of NAN.

4/ It is correct to say that I got a notice from High Court. It is correct to say that this notice was about making accused in this case. It is wrong to say that in that matter I have compromised with the accused. It is wrong to say that I have compromised therefore I am deliberately not telling about giving money to them. On being read our from a to a from his police statement Ex.P.-273 In NAN godowns of Dhamtari.....Money has to be given, the witness said that he had not given this statement to the ACB officers. How they have written I cannot say.
