

12. RESULTS OF EXAMINATION


1. The digital evidence storage media has been forensically analyzed using the authorized software & hardware tools available in the Government of India Laboratory at CFSL, Hyderabad.
2. The cardinal rules of Computer Forensics have been followed during the entire process of analysis.
3.
 - a. The physical backup of the suspected digital evidence storage media marked Q1PD, Q2PD and Q3PD has been taken as CAH372015Q1PD.dd, CAH372015Q2PD.dd and CAH372015Q3PD.dd by using Guymager Version 0.7.3-1.
 - b. The acquisition details along with the authentication hash values of the suspected digital evidence storage media marked Q1PD, Q2PD and Q3PD have been given at Page Nos. 01, 133 and 315 of the portable document file CAH372015-REPORT provided in the CD marked CAH372015-CD.
 - c. The physical backup of the suspected digital evidence storage media marked Q1PD, Q2PD and Q3PD have been forensically analysed by using EnCase version 6.19.6 and PhotoRec version 7.xx.




